- Link rate and service data between trucking partners and our Pricing and Domestic Departments.
- Regularly evaluate carrier base to ensure that there is an adequate selection of fully vetted, reputable, competitively priced, carriers in our Domestic Directory.
- Manage quote to routing comparison and make actionable recommendations as needed to ensure that vendor quote selection and routing selection are aligned.
- Ensure competitive rates with approved vendors are available to our Pricing and Operations departments; Ensure carrier capacity aligns with these elements.

- In conjunction with other company managers, ensure a scalable feedback loop is created to connect quote/rate realities with service realities; provide strategic recommendations for adjustments to carrier quote/routing approach as such.
- Maintain carrier relationships and develop new ones as needed.
- Create a manageable and meaningful domestic vendor scorecard.
- Create SOPs as needed for domestic implementations.
- Own domestic project bids and ensure that an SOP is developed to support the business.
- Own special projects including project cargo, warehouse transfers and other unique/special cargo bids.
- Negotiate favorable pricing with domestic carriers and warehouses.
- Maintain domestic directory, to include carrier expectation agreements and insurance certificates/verification.
