- Monitor if Importer Security Filing (ISF) for ocean freight has been transmitted.
- Track the successful export and import transit with agent and carrier. Confirm the ETA is accurate and update the system accordingly.
- Track commercial and shipment document distribution with foreign agents.
- Audit documentation for accuracy; upload documentation for visibility.
- Audit system for shipment accuracy and required info; deliver seamless transition to customs brokerage operations. Manage timely receipt of the

original ocean bill of lading, or telex release, upon initial departure of the vessel. Monitor freight payments.

- Complete approval of agent invoices with our accounting department.
- Manage additional customer-specific data feeds, such as customized agent spreadsheets, on an as-defined basis.
- Geography stays current on port operations around the globe (as needed).

SKILLS: Ability to remain engaged and focused. Excellent written and verbal communication skills. Ability to generate creative solutions and/or problem-solve. *Project management skills to handle a variety of customers on your desk.
